THIS CASE IS SET FOR HEARING ON Request for findings re: special immigrant juvenile status (minor, Pedro De Leon is 17 and will attain 18 on 04/08/00)

THE FOLLOWING ISSUES AND/OR DEFICIENCIES IN THE PAPERS ARE NOTED

1. Petitioner, **Pedro De Leon**, a minor (**17**), requests that the court issue an order finding that minor is eligible for special immigrant juvenile status under the Special Immigrant Juvenile Status Statute (SIJS), 8 U.S.C., § 1101(a)(27)(J), which provides in relevant part as follows:
 - a. "The term 'special immigrant' means ... an immigrant who is present in the U.S. –
 - i. who has been declared dependent on a juvenile court located in the United States or whom such a court has legally committed to, or placed under the custody of, an agency or department of a State, or an individual or entity appointed by a State or juvenile court located in the United States, and whose reunification with 1 or both of the immigrant's parents is not viable due to abuse, neglect, abandonment, or a similar basis found under State law;
 - ii. for whom it has been determined in administrative or judicial proceedings that it would not be in the alien's best interest to be returned to the alien's or parent's previous country of nationality or country of last habitual residence; and
 - iii. in whose case the Secretary of Homeland Security consents to the grant of special immigrant juvenile status..."
2. The specific findings required under the statutory scheme would be: (1) that petitioner is an immigrant placed under the custody of an individual appointed by a

- state court (probate guardianship); (2) that petitioner's reunification with one or both parents is not viable due to abandonment; and (3) it is not in the petitioner's best interest to be returned to his/her home country.
3. Once the above findings are made, petitioner may then begin the process with the Bureau of Citizenship and Immigration Services to obtain legal permanent residence status. In other words, the findings requested are a prerequisite to filing a petition for a "green card."
 4. State Superior Courts have jurisdiction to make factual findings of eligibility under SIJS See *N.O. v. Super. Ct. of Calif., County of Alameda*, No. A122430 at 2-3 (Cal. Ct. App. 9/25/08). Thus, under the federal legislation, any superior court judge would have jurisdiction to hear the SIJS petition.
 5. Minor/petitioner Pedro De Leon offers a declaration in support of the requested findings stating, inter alia, the following:
 - a. Minor was born on 04/08/00, in Guatemala and lived there with minor's mother until July 2017.
 - b. Minors was abandoned and neglected by father as he did not provide for him because he was always drunk. Father is now deceased. Mother worked but was never enough to care and provide food.
 - c. Minor was forced to move to the United States to work and provide for himself, but minor was apprehended by Immigration officials.
 - d. Minor is afraid to return to Guatemala as his mother cannot provide for him. He is targeted by gang members and fears violence at the hands of dangerous gangs that control much of his home country.
 6. Per the statutory scheme, this petition is to proceed only if guardianship of the minor is granted pursuant to the accompanying petition.
 8. **Need** Notice of Hearing and Proof of service as to Magdalena De Paz (mother), Jacinto Marcos (MGF), Manuela Brito (MGM), siblings (age 12 or older), or file Due Diligence Declarations.
