4. No response is filed by the Indian Tribe or Bureau of Indian Affairs at the time of the review of the file. If no response is filed within 60 days after receiving that notice, then the court may determine that the Indian Child Welfare Act does not apply to the proceedings, provided that the court must reverse its determination of the inapplicability of the act and must apply it prospectively if a tribe or the Bureau of Indian Affairs subsequently confirms that the child is an Indian child.
5. Petition indicates minors have Indian ancestry with Cherokee Nation. See attached letter dated 07/24/17 [prior to this filing] from Cherokee Nation regarding pending decision whether they will intervene. [Petition, 11/03/17, LFpg18].
6. **Need** Parental Notification of Indian Status (form ICWA-020).
7. Pr.C. §1513(h) requires that in guardianship cases where the minor has Native American ancestry, the Court Investigator "shall consult with the Indian child's tribe and include in the report information provided by the tribe." **Need** proof of service on Court Investigator.

8. **Need** Court Investigator report.
9. UCCJEA Declaration filed 11/03/17 only provides 4 years of residential history.
