2. Petitioner indicates CPS involvement, [Pet LF p. 6, 11, 16, 21 and 26]. Court to inquire.
3. Notice of Hearing and Proof of service by mail filed 08/28/17 as to Critza Coleman (mother) is insufficient. **Need** personal service. Alternatively, as mother is allegedly incarcerated, Court could allow certified mail return receipt with declaration of hardship of personal service per Local Rule 20-1317.
 - a. 1. Petitioner, **Juan Palafox**, requests that the court issue an order finding that minor is eligible for special immigrant juvenile status under the Special Immigrant Juvenile Status Statute (SIJS), 8 U.S.C., § 1101(a)(27)(J), which provides in relevant part as follows:
 - a. "The term 'special immigrant' means ... an immigrant who is present in the U.S. –
 - i. who has been declared dependent on a juvenile court located in the United States or whom such a court has legally committed to, or placed under the custody of, an agency or department of a State, or an individual or entity appointed by a State or juvenile court located in the United States, and whose reunification with 1 or both of the immigrant's parents is not viable due to abuse, neglect, abandonment, or a similar basis found under State law;
 - ii. for whom it has been determined in administrative or judicial proceedings that it would not be in the alien's best interest to be returned to the alien's or parent's previous country of nationality or country of last habitual residence; and
 - iii. in whose case the Secretary of Homeland Security consents to the grant of special immigrant juvenile status..."

2. The specific findings required under the statutory scheme would be: (1) that petitioner is an immigrant placed under the custody of an individual appointed by a state court (probate guardianship); (2) that petitioner's reunification with one or both parents is not viable due to abandonment; and (3) it is not in the petitioner's best interest to be returned to his/her home country.
3. Once the above findings are made, petitioner may then begin the process with the Bureau of Citizenship and Immigration Services to obtain legal permanent residence status. In other words, the findings requested are a prerequisite to filing a petition for a "green card."
4. State Superior Courts have jurisdiction to make factual findings of eligibility under SIJS See *N.O. v. Super. Ct. of Calif.*, County of Alameda, No. A122430 at 2-3 (Cal. Ct. App. 9/25/08). Thus, under the federal legislation, any superior court judge would have jurisdiction to hear the SIJS petition.
5. Minor Stephany, offers a declaration in support of the requested findings stating, inter alia, the following:
 - a. Minor was born on 02/04/00, in Mexico and lived there with her mother until age 5.
 - b. Stephany's father abandoned her when her mother was pregnant with her. Since then, Stephany's father has never reached out to her or supported her in any way.
 - c. Stephany's mother has been convicted of a drug trafficking violation and after she serves her sentence she will be deported to Mexico.
 - d. Stephany is afraid to go back to Mexico as she would be subject to a life of living alone and working to support herself. Both her maternal grandparents are deceased and she has absolutely no contact with any of her paternal relatives.
 - e. Neither parent is capable of supporting, protecting or raising Stephany.
6. Per the statutory scheme, this petition is to proceed only if guardianship of the minor is granted pursuant to the accompanying petition.
7. Guardianship petition is set for 03/21/18 and is pending a CI Report. Court may wish to trail matter to 03/21/18.
8. Need notice.
