- 5 No response is filed by the Indian Tribe or Bureau of Indian Affairs at the time of the review of the file. **If a response is filed**, the court must proceed as if the child is an Indian child and direct the appropriate individual or agency to provide active efforts under rule 5.484(c) to secure tribal membership for the child. **If no response** is filed within 60 days after receiving that notice, then the court may determine that the Indian Child Welfare Act does not apply to the proceedings, provided that the court must reverse its determination of the inapplicability of the act and must apply it

prospectively if a tribe or the Bureau of Indian Affairs subsequently confirms that the child is an Indian child.

- 6 ***If*** a Court Investigator and/or DCFS is appointed, then the investigator must consult with the Indian child's tribe per Pr.C.§1513(h). Need Court Investigator's report.
