THE FOLLOWING ISSUES AND/OR DEFICIENCIES IN THE PAPERS ARE NOTED:

1. Robert Schnieders, PPF, appointed successor guardian of estate only on 10/20/15; \$1,320,000 bond. Victoria and Antonio Pappalardo remain as guardians of person. Assets were result of Nevada lawsuit.
2. On 10/05/17, bond was ordered reduced to \$6,000 until blocked accounts are marshalled into the estate. **Need** status of bond/blocked accounts.
3. **Need** final Inventory and Appraisal.
4. **Need** accounting.
5. Declaration filed 05/01/18 indicating the guardianship is likely entitled to a maximum recovery of \$50,000; out of \$1M absconded by Robert Graham. Additionally, Robert Graham Bankruptcy estate has received \$4,587.87 plus \$3,971.48 from sale of his Colorado home; letter attached [LFpg10]. Counsel recommends to retain Eric Pepperman to proceed with unblocking procedure at no charge and to retain Mr. Pepperman to proceed with contingency recovery of the \$300,000 life insurance policy at a reduced rate of 25%.
