On 12/12/12 Court revoked letters of guardianship. PG appointed over minor's estate. Minor's father, Thomas, Jackson, passed away 3/10/10. Mrs. Skinner ordered to provide letter as to why petitioner initially thought there was a life insurance policy for minors. Atty Herring to inquire whether DCS handles estates and to contact father's family members to determine if there is a life insurance policy or funds for minors. Counsel indicates she will follow up with DCFS to obtain relative information of minor's father and attempt to obtain father's death certificate. On 10/3/12, attorney Herring indicates concerns on the record regarding funds distributed for the minor children. Jeanne Kennedy appointed GAL for minors. Ms. Herring will be contacting DA re issues on this case.

On 6/26/13, the Court issues a bench warrant for Rhonda Skinner; bail at \$210,000.

On 5/27/14 (No appearance) Court sets surcharge hearing for this date. Bench warrant remains in full force and effect (as to Rhonda Skinner)
