Continued from 12/18/17. Request to take judicial notice filed in courtroom and request granted. Aurora Foster and Michael Mitchell appeared, Kabmriana Inventory and Appraisal paternal aunt. Matter re-referred for Court Investigator to interview mother, father and minor's therapist. Last opportunity for mother to be interview. Parties to sign up for talkingparents.com by days' end. Parties to send weekly emails re what happened in minor's life. Text and email outside of Talkingparents.com in emergencies only. Previous order reiterated that upon drop off and pick up, parties immediately text the other party informing them of minor's whereabouts. When Georgette is involved in transportation, she is also to immediately text. Gary and Sandra Childress inform the Court that they intend to take minor to Texas next year for a week.
