4. Petitioner seeks power to apply for and receive any public benefits, social security & SSI benefits the minor child may be entitled to receive. Recommend order reflect that if accumulated principal exceeds \$15,000 on account, Petitioner to file for estate powers as Pr.C. § 2628(a)(1) will require an accounting.
