Mediation services are being offered as follows:

- > Remotely by videoconference or telephone
- > In-person at the court

You can fully participate in your mediation appointment in the manner you prefer.

Your mediation appointment:

- When ordered to mediation by a judicial officer, you should go immediately after your hearing to the Family Court Services office to obtain an appointment date and time
- You will be provided a tip sheet on how to participate in mediation by videoconference or phone if you choose to receive remote services
- You will receive information about how to complete a mandatory orientation program online prior to your mediation appointment
- You are required to complete a mandatory FCS questionnaire which will be provided when you schedule your appointment.
- You must submit it when scheduling your appointment.
